Greetings:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify the inhabitants qualified to vote in elections and town affairs of the North Dighton Fire District, which said district is defined in Chapter 671 of the Acts of the General Court of Massachusetts for the year 1912, the Legislature Act created the same, as amended by Chapter 349 of the Acts of said Court for the year 1951, as further amended by Chapter 216 of the Acts of said Court for the year 1962, to meet at the North Dighton Fire District building at 340 Forest Street, North Dighton on Wednesday, May 17, 2023 at 7:00 PM for the Annual Meeting of said District, then and there to act on the following articles:

ARTICLE I. To choose a Moderator.

ARTICLE II. To see if the District will rescind the vote taken at the Special Meeting Dated, March 15, 2023, to eliminate the Fire District Tax and implement a new Operational Charge. *(By rescinding the vote, the District will keep the current Fire District Tax in place.)*
