Proposed Restructuring Plan

Mr. Pacheco read a letter from the Board of Health to the Board of Selectmen recommending a reduction in the hours of the Health Agent from 35 hours to 25 hours.

Board of Health Agent Todd Pilling thought the current hours were necessary to get the job done. He said it would be nice to have someone in the Board of Health with a degree in order to advance the Board of Health.

Selectman Caron asked who would fill the hours that were being cut.

Mr. Paul Pacheco, Board of Health member, said they would advertise for a part time position to manage and oversee the office, schedule inspections and handle the day-to-day operations. He said the person would handle the day-to-day questions, but would not be there for a full day.

Selectman Caron asked if they would have a degree.

Mr. Pacheco said that had not been determined yet.

Chairman Hull asked if there were placeholders in the budget.

Town Administrator Mullen said the budget was the next logical step in the plan.

Chairman Hull said he would like to have some deadlines set to finalize the job description and other things.

Mr. Paul Pacheco said he did not want to comment or make any promises for the board. He said the Board of Health could put it on an agenda to come up with some deadlines.

Board of Health member Patrick McGovern, said if he could find a way to avoid reducing the hours, that would be great and there needed to be someone accountable for day-to-day operations.

Mr. McGovern said he was provided with information for the Health Agent's job description last week and would be working on that. He said the Board of Health had gone through so many changes and had not been able to keep up. Mr. McGovern said he agreed that residents and employees were at stake with projects and their livelihood.

The April 26 Board of Selectmen's meeting was discussed as a deadline.

Veterans Agent Ray Hague and Colonel Robert Perry Medal of Honor Plaque Presentation

Colonel Robert Perry came forward to speak regarding Dighton's Medal of Honor. Colonel Perry presented and gave an overview of the three framed documents that would be added to the Medal of Honor display at the Police station.

Mr. Matthew Costa Esq. - Gay & Gay, P.C.

Retainer Agreement with Town Counsel

Chairman Hull read the agreement between the Town and Gay and Gay PC.

Mr. Mullen said the value of having an updated engagement and agreement as Attorney Costa mentioned, reflects the commitment of Gay and Gay to the Town. He said he valued the relationship and strongly recommended approval of this document.

Selectman Pacheco said he was in agreement.

Selectman Caron said he also agreed.

William Moore, Board of Assessors

Tax Exemption Update

Mr. Moore said historically we have been applying the COLA to the income part of this exemption, but not to the assets portion. He said the Board of Assessors was not proposing to put anything on the warrant, but would research what the correct number for the assets should be and would propose a change for next year.

There was discussion of a warrant article and it was decided it was not necessary to create one, but it would be an automatic adjustment each year.

Mr. James Aguiar, Building Commissioner Library Building Project Update

Building Commissioner Aguiar said the exterior renovations are 90% complete and would be done in about two weeks. Mr. Aguiar said the front porch columns had been removed and the town would work with the Historical Commission to come up with a way to reinstall them and make them as close to original as possible. He said they were also working on plans for the outdoor ramp. Mr. Aguiar said that will bring us to a point where the exterior renovations will be complete. He said we are pursuing grants for the interior and coming up with a number that would involve more work being done by the town and save the taxpayers some money. Mr. Aguiar said that figure would be ready in a couple of weeks.

Selectman Pacheco said the board would like a true figure. He thanked Mr. Aguiar and Mr. Mullen for their work.

Mr. Aguiar said the biggest expense for the interior would be the installation of the HVAC units.

Chairman Hull said the Capital Outlay meeting provided a number of \$175,000.00 for furnishings in the library. He said, we as a town, should work together to create a capital fundraiser to raise that money.

Chairman Hull said one question had been raised related to fire suppression. Mr. Aguiar gave an overview of what the work would entail to install sprinklers in the existing building.

Spotlight Jonathan Gale

ADA Coordinator -Commission on Disability

ADA Coordinator, Jonathan Gale came forward to give an overview of the Commission on Disability and some of the projects that they have been involved in recently such as a ramp and sidewalks at the Middle School. He said they have also been working on a project to bring resources to people with disabilities and substance abuse.

Mr. Gale said he has received calls related to matching people with available disability resources. He said the Commission has been in existence for two years, and had finally separated duties from the Commission on Disability.

Selectman Pacheco thanked Mr. Gale for his work in the town.

Chairman Hull asked if the Commission on Disability could work more closely with you with regard to grant writing.

Mr. Gale said the Commission on Disability could use a couple more members.

Selectmen's Reports

Chairman Hull

Chairman Hull said the Water District was still looking for a Water Superintendent and they were accepting applications. He said the Annual Election of the Board of Commissioners would be May 15, at their headquarters.

Chairman Hull said he was not able to attend the Dighton-Rehoboth District School Committee meeting, but said there was over a 3 million dollar increase in expenses in their recent budget. He said Bristol County Agricultural High School and Bristol Plymouth's increases were nowhere near that number and there would be great scrutiny of the energy numbers.

Selectman Caron

Selectman Caron said the Solid Waste Committee met and Selectman Caron said he was elected the new Chairman. They discussed the point-of-sale system and hoped to have it up and running before June.

Selectman Caron said the committee lost Jonathan Lawrence and, as of right now, he was being replaced by Highway Department workers at the transfer station.

Town Administrator Report

Mr. Mullen said the Massachusetts One Step Grant Program begins in January and runs through June. He said the One Step Program has pulled together all infrastructure and housing grants into one portal. He said we did submit an expression of interest with the final grant due at the beginning of June for a townwide zoning assessment. Mr. Mullen said this was our first priority and the second priority is the update of our Housing Production Plan.

Mr. Mullen said he wanted to bring these two priorities to the attention of the board.

There was discussion of the MBTA and Southcoast Railroad.

Mr. Mullen said we will try to restructure our planning efforts so we can easily adapt to any requirements of the MBTA.

Mr. Mullen said we began budget review with the Finance Committee last night. All the presentations will be updated to the Town of Dighton's website on the finance page as we move to the June 5th Annual Town Meeting.

Mr. Mullen said that Congressman Auchincloss' office was having a luncheon at Bristol Plymouth.

Capital Outlay Committee Update

Mr. Mullen said the Capital Outlay Committee met on Monday and had their first look at the FY24 Capital Outlay Requests. They will meet next on Tuesday, April 4.

Facilities Use Request from Fathers House Family Church

Mr. Mullen said the request was to extend the use of the Old Town Hall on Sundays for services.

Selectman Pacheco said he has heard no complaints and he supported this request.
