The meeting was called to order at 6:32 p.m. by Chairman Caron. He stated that the meeting was being recorded and gave instructions for logging in and providing public input.

Scheduled Appointments

6:30 p.m. William Runey, Superintendent of Schools

Mr. Runey, Dighton-Rehoboth District Superintendent announced that a Statement of Interest has been submitted to the MSBA for a potential upgrade to Dighton Elementary School

Mr Bill Runey, Dighton Rehoboth District Superintendent presented a Power Point presentation regarding the MSBA Grant Program.

He stated that we are only in the que right now and if we are invited into the feasibility study, he said he would assemble a School Building Committee. Mr. Runey said at that point, we would hold visioning sessions, which would include public, professionals, school personnel, school committee members, students, etc.

Mr. Runey outlined populations projections for Dighton Elementary and some issues that are facing Dighton Elementary School. Including traffic issues, building deterioration and lack of safety and security cameras in the school

There was discussion of warrant articles for safety and security on both Dighton and Rehoboth's Town meeting warrants.

There was discussion of traffic issues and what could be done to control traffic currently.

Mr. Runey spoke about the Master Plan that was created by the Town of Dighton in 1993. He mentioned the "road to nowhere at the Dighton Elementary/Middle School Campus and the reasons that he felt that discussion for improvements failed because a good case was not made by the district for why it was necessary.

Mr. Mullen said he thought that the fact that Dighton has never been to the MSBA, he firmly believed that puts Dighton in a good position with this letter of interest.

Selectman Mello said it seemed there were a lot of parents picking up and dropping off. She wondered if something could be done to help the parents.
