

**BOARD OF SEWER COMMISSIONERS – MINUTES 2021**  
**May 17, 2021**

Meeting opened at 4:45 P.M.

**Present via Zoom: Paul Joly, Thomas Ferry, Robert Woods, Supt. Harold Gracia and Dianne Curtis.**

**Minutes:** Thomas Ferry motioned to accept the Minutes of May 3, 2021; Robert Woods seconded the motion; all ayes; none opposed; motion passes.

**New Business:**

**Approval for Licensed Drain-Layer Application Renewal for Raposo Company Landscape & Construction, LLC:** The Board reviewed a Renewal Application to be a Licensed Drain-Layer for Raposo Company Landscape & Construction, LLC. Paul Joly stepped down as Chair and motioned to approve the Licensed Drain-Layer Renewal Application for Raposo Company Landscape & Construction, LLC; Robert Woods seconded the motion; all ayes; none opposed; motion passes.

**Discuss Roofing Needs at the Town Hall Pump Station:** Supt. Harold Gracia discussed with The Board, quotes that were received for the Town Hall Pump Station roof. He stated that only one quote was received from Eric Correia of American Roofing for \$1,700.00. Robert Woods motioned to accept the quote from American Roofing for the Town Hall Pump Station roof; Thomas Ferry seconded the motion; all ayes; none opposed; motion passes. There was discussion regarding the details (colors, etc.) for the roof repair.

**Superintendent's Report:**

**Bristol County Agricultural High School (B.C.A.H.S.) Pump Station:** Supt. Harold Gracia stated that he went to inspect the expansion (overflow) tank for the B.C.A.H.S. Pump Station. He stated that he has some questions for Weston & Sampson, Engineer for the Dighton Sewer Dept. Supt. Gracia stated that he has not received the spare pump for the B.C.A.H.S. Pump Station yet. He said that he will contact the company for the status of the spare pump, this week.

**Power Plant Pump Station:** Supt. Gracia discussed with The Board that the Power Plant Pump Station needs a new flow meter. He stated that he obtained a verbal quote from True North for a flow meter, however, he is awaiting the written quote to see what other charges (such as labor, parts, etc.) will be incurred.




Robert Woods motioned to adjourn at 5:25 P.M.; Thomas Ferry seconded; all ayes. Meeting adjourned.


