Preservation Planning

- 1 FY21 Survey and Planning Grant Status
Proposal Response deadline: August 11, 2021.
 - Selectmen will receive and sign the contract between Massachusetts Historical Commission and town of Dighton: August 11, 2021.
 - Selection process will include DHC, Mullen and town historian.
1. *Historical House Marker Program*
 - Motion to send Delfin's letter to homeowners in historic district, on current letterhead, made by Nickerson; so moved by Olsen. All in favor.
 - Robert Woods may apply. Per deed: Dighton Factories is original owner. Olsen says being a "mill house" owner is something to be proud of.
 - DHC handed out approximately 6 applications. Homeowners have preconceived misconceptions regarding restrictions.
 - MHC has a handbook on establishing a local historic district. Inventory forms must be updated, says Jennifer Doherty of MHC. DHC will refer to the Local Historic District handbook.
