Secretary's Report

Community Preservation Committee Report

- Mr. Pruitt, Rep on CPC, asked CPC to consider to revise or fully fund, the Historical Commission application, in the event MHC declines grant.
- Mr. Pruitt feels CPC members are on line with survey of historic properties/ areas of interest.
- CPC members, according to Mr. Pruitt, are considering \$30,000 engineering study for potential bike path and parking lot, including signs, painted lanes and safety measures.
- Ms. Gales will attend March meeting to again talk about grant.

- Ms. Gales will contact Mr. Tom Ferry, regarding a display case and would like to soon have an "unveiling" for the plaque.

2. Walking Tour of National Register Districts -- Planning
